Financial Report:

Ron reviewed the financial reports and census numbers. Net loss for the month of November was \$148,880, resulting in a YTD loss of \$(323,248).

Wipfli presented a draft of the audited financial statements via Zoom. BSMC ended the fiscal year with a net loss of \$187,315 compared to a net loss of \$259,096 the previous year. BSMC has total Assets of \$7.5 million compared to \$7.7 million the previous year. The full draft of the audited financial statements was distributed to the board approval at the January 2025 board meeting.
